Rent-a-Cellular Terms and Conditions

The Terms and conditions hereinafter set forth constitute an Agreement ("Agreement") for the rental and use of Rent-a-Cellular cellular phone Equipment ("Equipment"). This Agreement is between the person signing the Agreement ("Renter"), and Microtronic Overseas Corporation, DBA Rent-a-Cellular (Rent-a-Cellular), located in Miami, Florida. Both parties acknowledge that this Agreement consists of all the Terms printed below as Terms and Conditions ("Terms"), as well as those contained in the Rental Agreement.

1. NATURE OF THIS AGREEMENT

This Agreement is solely for the purpose of creating a bailment that allows Renter to use the Equipment as permitted by this Agreement. Renter acknowledges that Equipment is owned by Rent-a-Cellular. No one other than Rent-a-Cellular may transfer the Equipment, or any rights and obligations under this Agreement. Rent-a-Cellular makes no express or implied warranties concerning the operation of Equipment, nor assumes responsibility for any loss or delay caused by Equipment or service malfunction.

2. YOUR RESPONSIBILITIES

Renter agrees to accept responsibility for the Equipment as provided by Rent-a-Cellular, which will be delivered to Renter's specified address in working condition. Ordinary wear and tear excepted, Renter agrees to return the Equipment to Rent-a-Cellular at the conclusion of the rental period in the same condition as when received.

Renter is responsible for loss or damage to Equipment. Replacement cost for standard handset package is US\$250.00, for other items, cost of replacement. The Renter agrees to be responsible to Rent-a-Cellular for payment of all rental charges and the costs associated with all calls during the term of the rental. If Equipment is lost or stolen, Renter is responsible for all service charges until the loss or theft is reported to Rent-a-Cellular by calling customer service at (305) 377-2284 or 1-877-902-7368.

The Renter agrees to pay Rent-a-Cellular all costs and expenses, including without limitation, reasonable attorney's fees, the fees of any collection agency, and court costs incurred by Rent-a-Cellular in exercising any of its rights or remedies hereunder when enforcing any of the Terms, conditions or provisions hereof, and consent to jurisdiction of the courts of Florida or Virginia, as determined in the sole discretion of Rent-a-Cellular, and waive the rights to object to such jurisdiction.

3. TERMS OF RENTAL

This rental is for a period specified in Agreement. Equipment is expected to be returned to Rent-a-Cellular on the second business day following Agreements end. Should the Agreement end date change to a date later than specified in the Agreement, the Renter should notify Rent-a-Cellular of that change. For every day that Equipment is not returned to Rent-a-Cellular, past the promised date of return, a penalty charge of US\$5.00 a day will be applied on top of normal rental charges.

Rent-a-Cellular will furnish a container properly designed for shipment of the Equipment, along with the items necessary to return the Equipment to Rent-a-Cellular at the conclusion of the rental period. Return shipment will be via the same, or similar, delivery service as used to deliver Equipment to Renter. Shipment to and from Renter will be charged at a rate of US\$10.00 each way under normal processing (normal processing is considered shipments for delivery on second business day). Additional charges will be applied for next day shipments. Rent-a-Cellular only ships within the Continental United States. International shipments are not allowed by Rent-a-Cellular. Renter assumes responsibility for Equipment if the method of return of Equipment is by other means.

Should Renter leave or deposit Equipment at a location not agreed to by Rent-a-Cellular in advance, Renter is liable for all costs to return the Equipment to Rent-a-Cellular, plus any additional rental charge for Equipment caused by delay.

4. EQUIPMENT INSURANCE

Rent-a-Cellular Equipment is insured for theft. The charge for such insurance is US\$1.65 per day or US\$6.60 per week that the Equipment is in the possession of the Renter. In the event of the Equipment is stolen, the Renter must file a police report and call Rent-a-Cellular immediately in order to stop the service. Renter will not be responsible for service charges after reporting to Rent-a-Cellular. A deductible of \$75.00 will be charged.

5. OPERATION OF EQUIPMENT

Equipment furnished to the Renter by Rent-a-Cellular is a digital cellular telephone engineered to operate in specified countries. The Renter acknowledges that Equipment should not be operated in a country not specified at the time of rental.

6. PAYMENT OF CHARGES

As condition of furnishing Equipment to Renter for the period of time specified in this Agreement under a credit card arrangement, Renter authorizes Rent-a-Cellular to reserve credit or process a deposit with card issuer, or bill any

rental, airtime, other applicable charges estimated to be due Rent-a-Cellular prior to Equipment being shipped to Renter, or at any time during or following the rental term.

Renter represents to Rent-a-Cellular that Renter is an authorized signer on the account of the credit card furnished as part of the Agreement. In addition, Renter agrees to be personally responsible for costs, expenses and charges incurred by this rental transaction, regardless of the form of payment. A late payment charge of the lesser of 2% per month, or the maximum rate permitted by law, will be applied to amounts due to Rent-a-Cellular, if not paid by due date.

Rent-a-Cellular will make every effort to process charges for calls made under this Agreement in a timely manner, following the receipt, by Rent-a-Cellular, of the detailed information regarding those calls. However, Renter acknowledges and agrees that due to the time required for exchange of billing information among and between the various cellular operators, that the processing of call charges will take place approximately four to six weeks following the conclusion of the rental. Under some circumstances, additional call charges made during the period of this rental might appear in subsequent billing periods. After rental is completed, any adjustments will be made by subsequent billings.

7. COMPUTATION OF CHARGES

For purposes of computing rental charges for Equipment, Rent-a-Cellular will consider as a whole day, any portion of a day (a day being defined as a twenty four hour period that begins and ends at midnight) contained in the period of rental specified in Agreement.

Rental days begin on the day Renter specifies Equipment is needed for Renter's Departure, and are counted until Equipment is shipped back to Rent-a-Cellular.

Confirmed reservations canceled within 48 hours of shipping date, are subject to a US\$30.00 reservations processing fee. Rentals canceled after Equipment has been shipped are subject to forfeiture of first week's rental charge.

8. RENT-A-CELLULAR RIGHT TO REFUSE OR TERMINATE SERVICE

Rent-a-Cellular may refuse or terminate service without notice for: 1) providing inaccurate credit information to Rent-a-Cellular; 2) the appearance of misrepresentation in relation to your service; 3) refusal of credit card issuer to reserve credit, or process charges for payment of any sum due Rent-a-Cellular hereunder; 4) non payment of any amount due Rent-a-Cellular on other cellular account(s) for which you are responsible; 5) your insolvency, receivership, voluntary or involuntary bankruptcy; 6) using service in a manner that will adversely affect Rent-a-Cellular, or is otherwise in violation of any U.S. Federal Communications Commission Rules or Regulations, or State, Federal or Local laws, or any country's laws, rules or regulations.

9. SIGNATURE ON FILE

By signing below, Renter agrees that for future rentals, signature on file constitutes continuing acceptance of Rent-a-Cellular Terms and Conditions for such future rentals, unless Rent-a-Cellular receives written notification by Renter otherwise. An additional signature will not be required.
